

**VILLAGE OF MARENGO  
BYLAW 2020-06**

**A BYLAW TO DECIDE MATTERS PURSUANT TO THE *LOCAL GOVERNMENT  
ELECTION ACT, 2015***

The Council of the Village of Marengo in the Province of Saskatchewan enacts as follows:

**1. INTERPRETATION**

- 1.1. This bylaw shall be known as the General Election Bylaw
- 1.2. The Authority for this bylaw is provided within *The Local Government Election Act, 2015*, and any amendments to the Act.
- 1.3. This bylaw addresses matters which Council made decide by bylaw or resolution pursuant to section 9.1 of *The Local Government Election Act, 2015*.

**2. DEFINITIONS**

- 2.1 “Act” shall mean *The Local Government Election Act, 2015*
- 2.1 “Council” shall mean the council of the Village of Marengo
- 2.2 “Municipality” shall mean the Village of Marengo

**3. POSTING OF NOTICES**

- 3.1 As it is not feasible to publish required notices in a newspaper having general circulation in the municipality, notices required by the Act shall be posted and distributed in the following manner:
  - 3.1.1 In a conspicuous location in the building that is the main office of the municipality.
  - 3.1.2 In one or more conspicuous locations in the municipality that are different from the location in 3.1.1.
  - 3.1.3 Distributed by mail to all voters of the municipality.
  - 3.1.4 Published on the municipality’s website.
  - 3.1.5 Published on the municipality’s Facebook page with a link to the information on the municipality’s website.
  - 3.1.6 Any other means of publishing within the same time frame and frequency required by the Act and authorized by council resolution.

**4. NOMINATION PAPER**


- 4.1 The nomination paper shall include the candidate’s occupation.


**5. BALLOTS AND BALLOT BOXES**

- 5.1 In the event of multiple positions being elected on the same day, each position's ballot shall be in a different colour.
- 5.2 Names on the ballots shall be "LAST NAME, First Name" in alphabetical order of the last name.
- 5.3 The candidate's occupation shall be listed behind the candidate's name.

**6. COMING INTO FORCE**


- 6.1 This bylaw shall come into force on July 14<sup>th</sup>, 2020.



